

UWUA 2007 CONSTITUTIONAL CONVENTION OVERVIEW

- **THE CONVENTION CONVENES Wednesday June 27, 2007**, at 10:00 AM and reconvenes at 8:30 AM each day till adjournment on Saturday, June 30, 2007.
- **HOTEL RESERVATIONS / GROUND TRANSPORTATION**: The **cutoff date for hotel reservations has been extended to JUNE 6, 2007**. Hotel reservations can be made by calling toll free (800-876-2100). **Transportation to and from the airport** can be arranged through Executive Transportation at a convention cost of \$24 round trip per person (lower rates available for groups). Call toll free (800-990-8841).
- **UNION STEWARD CLASSES**: Classes on grievance processing and labor contract administration will be conducted from 1:30 PM to 3:00 PM on June 27, 28 & 29. Completed forms should be returned to the National Office by **MAY 30, 2007**.
- **DEADLINE FOR FILING DELEGATE NOTIFICATION FORMS**: Article XV, Section 9, of the National Constitution requires that all Delegate Notification Forms **must** be received by the National Secretary-Treasurer no later than **FIFTEEN (15) DAYS** prior to the opening of the Convention. The Twenty-Eighth Constitutional Convention of the Utility Workers Union of America, AFL-CIO, is scheduled to open at 10:00 AM on June 27, 2007; through Saturday June 30, 2007, therefore, the deadline for Delegate Notification Forms to be properly returned will be **JUNE 12, 2007**. If your local union has not sent the required notification to the National Office, it is suggested that this be done as soon as possible.
- **DEADLINE FOR SUBMISSION OF RESOLUTIONS AND CONSTITUTIONAL CHANGES**: Article XV, Section 12, of the National Constitution requires that all proposed Resolutions and Constitutional changes shall be submitted to the National Secretary-Treasurer no later than **TEN (10) DAYS** prior to the opening of the Convention. Since the Convention is scheduled to open on June 27, 2007, the latest date such Resolutions or Constitutional changes can be accepted will be **JUNE 17, 2007**.
- **PER CAPITAL PAYMENT REQUIREMENT: Delegate Credentials cannot be issued until the March 2007 per capita has been received by the National Secretary-Treasurer (due April 15, 2007); late payments will be accepted.**
- **WEDNESDAY EVENING THE HOTEL WILL SPONSOR A RECEPTION FOR ALL THE DELEGATES AND THEIR FAMILIES**
- **WE WILL BE SPONSORING A PICNIC AT CONEY ISLAND AMUSEMENT PARK ON THURSDAY, JUNE 28, 2007.** The park has the world's largest outdoor recirculating pool and opens at 10:00 AM. We will have transportation for family members starting at 10:00 AM and for delegates at 2:00 PM. A picnic lunch, beer, wine, and soft drinks will be provided at 3:00 PM. Buses will start returning guests at 5:30 PM when they are full. This will provide a great opportunity to meet and greet delegates, their families, and share information.
- **CINCINNATI REDS vs. ST. LOUIS CARDINALS FRIDAY JUNE 29, 2007 AT 7:10 P.M.** at the Great American Ball Park several blocks from the Millennium Hotel. The deadline has passed but call the National office 202-974-8200 to see if additional tickets can be acquired. Discounted group tickets are normally \$13.00 and \$32.00, but the UWUA is contributing half of the ticket price for this special game during our Convention.
- **DINNER / DANCE TO BE HELD ON SATURDAY EVENING, JUNE 30, 2007**: For those of you who have not previously attended a convention, notice is hereby given that a dinner/dance will be held on Saturday evening. Therefore, most convention attendees arrange their departure for the Sunday following the convention.
